**I. NAME A FACILITY OR SPACE**

**A. MEDICAL EDUCATION CENTER AT JEWISH HOSPITAL \$2,500,000**

By way of your gift, of \$2,500,000, we will name in perpetuity, or that of someone you would like to honor the Medical Education Center at Jewish Hospital. Your name will appear internally in the Center and very prominently located and seen externally on Kenwood Road. The Center was recently opened in 2019 and includes two conference rooms, multiple classrooms, a simulation center, and the Dr. Charles Glucek medical library. It also features a 165-seat Ronald H. Fegelman, MD Memorial Auditorium, which features video technology to connect to surgical procedure spaces inside and outside the hospital.

**B. SIMULATION TRAINING CENTER AT JEWISH HOSPITAL \$500,000**

By way of your gift, of \$500,000, we will name in perpetuity, or that of someone you would like to honor the Simulation (SIM) Training Center at Jewish Hospital. Your name will appear on the SIM Center that is the gold standard for healthcare education. It provides a safe environment for students and trainees in the health sciences to practice skills and experience simulated medical cases using fully interactive, highfidelity manikins. Two simulated operating rooms, an ER examination bay, and treatment rooms offer a high-tech opportunity to learn and discuss policies and procedures. It facilitates excellence in healthcare education, practice, advocacy, assessment, and research, using simulation technologies and methodologies, ultimately improving the safety of our patients.

**C. FAMILY & COMMUNITY MEDICINE CENTER AT ANDERSON HOSPITAL \$250,000**

By way of your gift, of \$250,000, we will name in perpetuity, or that of someone you would like to honor the new Family & Community Medicine Center at Anderson Hospital. Your name will appear on the Clinic where residents learn to be caring family physicians. Throughout their training, residents learn effective models of outpatient care, disease prevention, health promotion, and practice management skills. The Center is organized in work pods, designed around a centralized consult space, and includes exam rooms and procedure rooms. It has a dedicated computer room, and small group counseling rooms. It will serve a population that reflects the area's diverse socioeconomic environment.

**D. FAMILY & COMMUNITY MEDICINE SIMULATION LAB \$100,000**

By way of your gift, of \$100,000, we will name in perpetuity, or that of someone you would like to honor the new Family & Community Medicine Simulation Lab at Anderson Hospital. Your name will appear on the lab where residents learn to be caring family physicians. In addition, the space will be used as a community facing asset to support ongoing learning and certification for first responders, nurses and physicians at no charge. This further demonstrates the commitment and importance of communitybased partnerships in medicine.

**E. MEDICAL EDUCATION PROGRAM & ADMINISTRATIVE OFFICE SUITE (2X) \$100,000**

By way of a gift, of \$100,000, we will name in perpetuity, or that of someone you would like to honor one of the GME Administrative Office Suites, either at Jewish or Anderson Hospitals. The Administrative Office Suites house the program director, support staff, and faculty. Here leaders focus on the organizational, administrative, and financial leadership of the GME Program. Administrative leaders implement strategic imperatives and ensure the educational and training experiences for residents and fellows.

**F. FAMILY & COMMUNITY MEDICINE LOBBY \$75,000**

By way of your gift, of \$75,000, we will name in perpetuity, or that of someone you would like to honor the new Family & Community Medicine Center Lobby at Anderson Hospital. Your name will appear on the clinic lobby where community members come to receive treatment by the caring family physicians.

**G. RESIDENT WELL-BEING CENTER AT THE JEWISH HOSPITAL-MERCY HEALTH \$75,000**

By way of your gift, of \$75,000, we will name in perpetuity, or that of someone you would like to honor the new Resident Well-Being Center at The Jewish Hospital. Your name will appear on the center where residents will have access to exercise equipment, well-being coaching and a variety of solutions to manage the every-day stresses of physician training.

**H. PRECEPTOR AT ANDERSON HOSPITAL**

**\$50,000**

By way of your gift, of \$15,000, we will name in perpetuity, or that of someone you would like to honor the Preceptor Room at Anderson Hospital. Your name will appear at the entrance wall of the Video Viewing and Collection Room. Videos of clinically oriented case-based scenarios provide educators a novel way to deliver medical education in the 21st century. Students and trainees review videos of specific cases prior to receiving instruction from faculty members. This instructional technique requires dedicated space, recording hardware, a computer to edit video, and support to store videos on a platform readily accessible to residents.

**I. RESIDENT LOUNGE AND CALL ROOMS AREA AT ANDERSON HOSPITAL**

**\$25,000**

By way of your gift, of \$25,000, we will name in perpetuity, or that of someone you would like to honor the new GME Resident Lounge and Call Rooms Area at Anderson Hospital. Your name will appear at the entrance of the Resident Lounge and Call Room Area. The Resident Lounge has a kitchen, a table to gather and dine, and refrigerator. The Call Rooms area accommodates residents and fellows who are on call in the hospital overnight. The area includes sleep rooms when extended time in the hospital is required. Call Rooms have a private (lockable) bathroom with shower, sink, and toilet.

**J. AUDITORIUM FRONT ROW AT JEWISH HOSPITAL**

**\$25,000**

By way of your gift, of \$25,000, we will name in perpetuity, or that of someone you would like to honor the prominent front row of 20 chairs in the new teaching auditorium. Your name will appear on an official naming plate that will be installed on the partition wall on the first row in the new Ronald H. Fegelman, MD Memorial Auditorium. This large auditorium is home to many educational endeavors and provides a venue for community outreach, health promotion and disease prevention lectures, distinguished speakers, and other events. It opened March 18, 2019. It is a 17,000-square foot facility and has 160-seats. It features the latest in state-of-the art educational and teaching tools and technology to connect to procedure spaces both inside and outside the hospital. The full auditorium is named for the late Dr. Fegelman, who served on the medical staff of The Jewish Hospital as a general and thoracic surgeon and had a lifelong love of learning.

**K. MEDICAL EDUCATION CLASSROOM (10X)**

**\$15,000**

By way of your gift, of \$15,000, we will name in perpetuity, or that of someone you would like to honor one of the twelve classrooms at Jewish Hospital. Your name will appear at a classroom entrance doorway. The GME classrooms are designed to meet needs to accommodate a more interactive learning style with comfortable seating to create an atmosphere to inspire learning. They focus on providing comfortable spaces for students and trainees to work together in pairs and groups, can be quickly reconfigured to provide the best teaching layout, allow for various seating options, and include training equipment, ample charging sockets, and easy access to a fast Wi-Fi connection.

## L. CONFERENCE ROOMS

**\$10,000 (6)**

By way of a gift, of \$10,000, we will name in perpetuity, or that of someone you would like to honor a GME conference room. Conference rooms are where the GME students and trainees learn, program operations are formulated, where important decisions are made, and progress is analyzed. Each of the technology-equipped conference rooms enhance teamwork and provide open space for group study situations allowing residents and fellows work together. Your name will appear at the doorway of one of the nameable GME conference rooms at Anderson or Jewish Hospital.

## M. CLINIC PATIENT TREATMENT ROOMS (16x)

**\$10,000**

By way of your gift, of \$10,000, we will name in perpetuity, or that of someone you would like to honor a treatment room in the new Family & Community Medicine Residency Clinic at Anderson Hospital. Your name will appear on the room where residents learn to be caring family physicians.

## II. ESTABLISH A NEW ENDOWMENT FUND

### A. GME LEADERSHIP SUPPORT ENDOWMENT

An endowed Leadership Support Endowment provides discretionary funds for current and future GME leaders to support the strategic direction of the GME program. It is not restricted to a particular effort, program, or research, and provides significant flexibility in fulfilling the collective mission of the Mercy Health medical education program.

#### **Named Designated Institutional Official Endowment**

**\$250,000**

By way of your gift, of \$250,000, we will name in perpetuity, or that of someone you would like to honor with a Named Designated Institutional Official (DIO) Endowment. Your Fund will offer a prestigious title which is awarded to a leading physician, recognizing the profound contributions of their GME leadership. The DIO is responsible for leadership of the GME program and is its top-ranking executive leader. The DIO reports directly to the Hospital President and is a member of the executive team. The DIO is responsible for the development and implementation of the residency training programs and acts as a liaison between the program directors, Hospital Administration, residents, and other departments, chairs the Graduate Medical Education Committee (GMEC), a committee of medical staff. Your Fund will provide unrestricted support for non-salary, one-time expenses of the GME program at the discretion of the DIO under current policies and procedures of the Foundation. Once funded, the DIO position title will bear your name like an endowed chair or deanship does at a university. Your Fund will provide the current DIO, all successors will be accorded this title. This title will be included in the Mercy Health Cincinnati, LLC Board of Trustees approval process for position appointments. Ultimately, your Fund is a desirable resource, providing dedicated dollars for education and training in perpetuity. Currently, Dr. Stephen Feagins is the DIO at Mercy Anderson Hospital and Imran Naqvi, MD, FACP is the DIO at Jewish Hospital.

## B. GME RESEARCH ENDOWMENTS

An endowed GME Research Fund will encourage young physician-investigators to engage in clinical research and promote clinical research and treatment interventions within the health care setting.

### Clinical Research Endowment

**\$150,000**

By way of your gift of \$150,000, we will name in perpetuity, or that of someone you would like to honor with a Named Clinical Research Endowment Fund. Your Fund promotes new educational programs to develop future research leaders. Your Fund will support the development of clinical trials and provides support for research space, beds, and equipment necessary to carry out experimental measurements and therapeutics in volunteer patients. Ultimately, your Fund energizes the discipline of clinical and translational research, ultimately enabling researchers to provide new treatments more efficiently and quickly to patients.

## C. PROGRAM ENDOWMENTS

An endowed Program Endowment may be established according to your interests and preferences for a particular program. Your endowed fund will be professionally invested for the long-term. Each year, a percentage of the average fund balance will be distributed to the designated program to support its ongoing needs.

### Named Endowed Program Fund

**\$75,000**

By way of your gift, of \$75,000 or more, we will name in perpetuity, or that of someone you would like to honor a Named Program Fund. There are four GME programs:

- 1) General Surgery Residency
- 2) Internal Medicine Residency
- 3) Pharmacy Residency
- 4) Podiatry Residency.
- 5) Orthopedic Fellowship

Each gift of endowment for a program is invested and earns income for the operating budget of that specific program in perpetuity.

## D. LECTURESHIP ENDOWMENTS

Lectures often provides the stimulus for innovations in research and education. Lectures allow you, the donor, to specify an area of study for the lecture series to address such as General Surgery Residency, Internal Medicine Residency, Pharmacy Residency, or Podiatry Residency programs.

### Named Endowed Lectureships

**\$50,000**

By way of your gift, of \$50,000, we will name in perpetuity, or that of someone you would like to honor a Named Lectureship. Your Fund may enable students, trainees, and faculty to interact and develop relationships with important leaders and professionals in a variety of fields. Expenditures from your lectureship fund shall consist of an honorarium and/or expenses for the lecturer. Ultimately, your Fund makes sure a nationally recognized expert is chosen each year to be the honored speaker for an educational event held in honor of you, the donor.

## E. SCHOLARSHIP ENDOWMENTS

We want to grow residents with a track record of excellence, and endowment gifts ensure that scholarship resources will always be available for talented young residents. These endowments shall provide scholarship awards above and beyond the provided graduate medical education stipend. Our Mercy Health residents are involved with many scholarly activities, and we want to encourage them to continue to achieve and publish during their residency training. From their perspective, they appreciate opportunities to present their research. We are sometimes asked by GME applicants if we can provide the same academic opportunities as a university-based residency. We want our residents to have easy access to research mentors and opportunities to participate in anything from a small-scale resident-led research project to a large multi-site clinical trial.

### Named Endowed Tribute Scholarship

**\$25,000**

By way of your gift, of \$25,000, we will name in perpetuity, or that of someone you would like to honor with a Named Tribute Endowed Scholarship. Your Fund will provide the resources necessary to attract talented students and trainees to Mercy Health Cincinnati. Your Fund may be established according to your interests and preferences for a particular hospital, program area, financial need, or any number of other eligibility specifications consistent with Foundation policy. Your Fund will be invested with the Foundation's endowment and earn income in perpetuity for student aid. Your fund will adhere to a payout rate established by the Bon Secours Mercy Health Foundation Board of Trustees. Your Fund will keep growing as earnings and capital appreciation over the payout rate are reinvested into the principal.

### Named Endowed 'Pathways to Success' Scholarship

**\$25,000**

By way of your gift, of \$25,000, we will name in perpetuity, or that of someone you would like to honor with a Named 'Pathways to Success' Endowed Scholarship. Your Fund will encourage medical students interested in working with the underserved to consider family medicine as a career choice. Your Fund will help promote the recruitment and retention of diverse students and trainees. It will increase cultural competency in the health care workforce and encourage diversity in the health professions. Ultimately, your Fund will improve the health of minorities and reduce disparities in care.

### Named Endowed Resident Academic Research Career Scholarship

**\$25,000**

By way of your gift, of \$25,000, we will name in perpetuity, or that of someone you would like to honor with a Resident Academic Career Endowed Scholarship. Your Fund will support the pursuit of an original research proposal (particularly if done in collaboration with a faculty mentor), a substantive quality improvement project, participation at a national conference, leadership or advocacy training, or a unique elective experience. Your Fund will help develop student projects, with topics including clinical investigation, translational research, family and community medicine and global health. Ultimately, your fund will maximize opportunities for scientific and academic medical careers.

## F. STUDENT SUPPORT ENDOWMENTS

Student Support Endowments are used for limited financial assistance when students are unable to meet immediate, essential expenses and to promote mental, physical, emotional, and spiritual wellbeing. We know it's important to combine academic studies with the student lifestyle to maximize the GME student experience. We want to encourage students and trainees to take care of their body as well as their minds.

### **Named Resident and Fellow Wellbeing Endowed Fund** **\$25,000**

By way of your gift, of \$25,000, we will name in perpetuity, or that of someone you would like to honor with a Resident and Fellow Wellbeing Fund. Your Fund will support and improve the wellbeing of residents and fellows at Mercy Health. Your fund will provide the internal and external resources to meet the mental, physical, emotional, and spiritual needs to navigate and thrive in the intense and challenging experience of residency and fellowship training while laying the foundation for a successful medical career. Ultimately, your Fund supports student wellness and personal wellbeing and helps prevent any unexpected hardship to jeopardize a student's academic journey.

## G. FACULTY SUPPORT ENDOWMENTS

Faculty Support endowments help Mercy Health celebrate, attract, and retain top faculty GME teaching faculty.

### **Named Faculty Development Endowment** **\$50,000**

By way of your gift, of \$25,000, we will name in perpetuity, or that of someone you would like to honor with a Named Faculty Development Endowment. Your Fund will support the offering of regular faculty development workshops and meetings to foster an environment in which GME faculty and staff can teach and learn from one another by sharing knowledge, ideas, and goals. Your Fund may support program directors and core faculty members to engage in professional development applicable to their responsibilities as teachers. Ultimately, your Fund will support the continual improvement of GME faculty as educators and mentors.

### **Excellence in Clinical Teaching Award** **\$50,000**

By way of your gift, of \$25,000, we will name in perpetuity, or that of someone you would like to honor with a Named Excellence in Clinical Teaching Award. Your Fund will honor resident and fellow physicians who skillfully teach and inspire other learners, including faculty, peers, medical students, clinical staff, patients, and their families. This award recognizes the fundamental concept that the development of outstanding physicians occurs primarily in clinical settings (ambulatory or in-patient). This honor is accompanied by a monetary award for support of a faculty members development and/or teaching programs.



### III. CREATING A NAMED NON-ENDOWED (EXPENDABLE) FUND

#### A. NAMED PROGRAM EXPENDABLE FUND

≥\$15,000

By way of your gift, of a minimum \$15,000, we will name, or that of someone you would like to honor Non-Endowed (Expendable) Fund. As a non-endowed expendable fund, these funds will carry either the name of the donor or that of his/her choosing for as long as the donated funds are available for use. The donated funds are given to create a fund with the expectation that it will be fully spent. The Fund requires a written agreement and carries either the name of the donor or that of his/her choosing for as long as the donated funds are available for use. It allows access to the full balance of the fund at any time, which is helpful for immediate needs like acquiring equipment or starting a special project. The Fund appeals to the donor who wants to make an immediate difference by providing a large onetime gift or a generous annual gift of a set amount. The Fund is internally assigned a separate account to ensure uniqueness for commitments and for accounting and reporting purposes. As a non-endowed fund, this important fund will carry either the name of the donor or that of his/her choosing for as long as the donated funds are available for use. This fund will be used to supplement, not replace, the annual expenditures of the GME Program for the repair of or the purchase of equipment needed for training and education. When the funds donated for this equipment fund are depleted, the named fund will cease to exist unless the donor chooses to make further donation to support the fund.
